Constitution of the Internal Complaint Committee

1. Name:

The committee shall be known as the "Internal Complaint Committee" of Sanjivani College of Engineering, hereinafter referred to as the "ICC"

2. Objectives:

a. The ICC is constituted to address complaints related to sexual harassment, uphold the dignity and safety of individuals, and ensure compliance with the guidelines set forth by UGC, AICTE, and the POSH Act.

3. Composition:

- a. The ICC shall consist of the following members:
 - i. Chairman: Nominated by the College Director (Preferably a senior faculty member or an external expert)
 - ii. Two faculty members (preferably one male and one female)
 - iii. One supporting staff
 - iv. One administrative staff member
 - v. One external member (NGO representatives, legal experts, or social workers)
 - vi. Four student representatives

4. Tenure:

a. Members of the ICC shall serve a term of three years, and the committee shall be reconstituted at the end of this term.

5. Meetings:

a. The ICC shall meet as and when required but at least once in a semester. The quorum for the meeting shall be two-thirds of the total strength.

6. Functions and Responsibilities:

The ICC is responsible for:

- Receiving and redressing complaints of sexual harassment.
- b. Conducting inquiries in a fair and impartial manner.
- c. Maintaining confidentiality throughout the complaint process.
- d. Recommending appropriate actions against offenders.
- e. Promoting awareness on the prevention of sexual harassment.

7. Procedure for Complaint Redressal:

The ICC shall follow the procedure outlined in the POSH Act for receiving, investigating, and resolving complaints.

Complaints may be submitted in writing or electronically, and the identity of the complainant shall be kept confidential.

8. Annual Report:

The ICC shall submit an annual report to the college administration detailing the number of complaints received, actions taken, and recommendations for preventive measures.

9. Awareness and Training:

Organize workshops and awareness programs on preventing sexual harassment.

Conduct periodic training for members of the ICC on handling complaints and maintaining confidentiality.

10. Amendments:

This constitution may be amended with the approval of a two-thirds majority of the ICC members.

11. Dissolution:

In the event of dissolution, a new ICC shall be constituted as per the guidelines provided by UGC, AICTE, and the POSH Act.

12. Ratification:

This constitution is ratified on 17/09/2021 and is effective immediately.

INTERNAL COMPLAINT COMMITTEE

Internal Complaints Committee (ICC) everybody has the right to be treated with dignity and respect and a right to safe and healthy work environment. Sexual harassment is a violation of an individuals' right to work and live with dignity. Sanjivani College of Engineering, Kopargaon is committed to providing a place of work and study that is free of sexual harassment. Instances of sexual harassment will be taken seriously and dealt with promptly. Disciplinary action will be taken according to the nature and gravity of the behavior reported. The College will respect the confidentiality and privacy of individuals reporting and the accused of sexual harassment to the extent possible. Care will be taken to see that complainants, witnesses and the harasser does not face victimization and discrimination during the process of enquiry. Intentionally providing false information is a ground for disciplinary action. In case of a false complaint a penalty will be levied on the complainant. All members of College - students, teaching faculty, administrative staff, will come under the purview of this policy. What constitutes sexual harassment? Sexual harassment as defined in the Sexual harassment of women at workplace (prevention, prohibition and redressal) Act, 2013 includes any one or more of the following 'Unwelcome' acts or behavior:

- (i) physical contact and advances;
- (ii) (ii) a demand or request for sexual favors;
- (iii) (iii) making sexually colored remarks;
- (iv) (iv) showing pornography; or
- (v) any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

This would also include online harassment via internet, sms and social network sites. Further, the following may also amount to sexual harassment:

- (i) Implied or explicit promise of preferential treatment;
- (ii) implied or explicit threat of detrimental treatment;
- (iii) Implied or explicit threat about present or future employment status;
- (iv) Interference with work or creating an intimidating or offensive or hostile work environment; or
- (v) Humiliating treatment likely to affect health or safety.

Internal Complaint Committee Report

The complaint raised by the Mrs. Megha Kurhe, Assistant Professor, Dept. of IT, against the Mr. Prajwal Rahane, FY (K-ECE) regarding the misbehavior during invigilation of CIA examination. According to the compliant Mr. Prajwal Rahane, FY (K-ECE) was suspended from theory and practical classes till the investigation ends. The case was thoroughly investigated by the internal compliant committee members on 12/01/2023. Following remarks has been drawn during the investigation.

- 1. The written complaint was given by Mrs. Megha Kurhe to the Dr A G Thakur, Director, SCOE. Firstly, Mrs. Megha Kurhe, Assistant Professor, Dept. of IT, called off and asked to narrate the incidence happened during the invigilation. During the interrogation Mrs. Megha Kurhe told that Mr. Prajwal Rahane, FY (K- ECE) was talking with Miss. Dhanashri Thakare FY (D-Civil) during the CIA examination. So, she has warned him to be quiet. During the entire invigilation Mr. Prajwal Rahane, FY (K- ECE) was showing inappropriate sign towards the Mrs. Megha Kurhe. At end of the exam, while collecting the papers he pushed her and went ahead, without any apology.
- 2. So, next Miss. Dhanashri Thakare FY (D- Civil) called and asked about the incidence, during interrogation told that she was taking help of Mr. Prajwal Rahane, FY (K- ECE) for some calculation on calculator. So, Mrs. Megha Kurhe asked Mr. Prajwal Rahane to return the calculator to Miss. Dhanashri Thakare and asked to write their own paper. Listening to her, Mr. Prajwal Rahane did not like it and taking Mrs. Megha Kurhe permission submitted the paper and went out of the class. Meanwhile, other invigilator of the same class asked him to go to his place till the paper time ends. She did not know what happened thereafter.
- Mr. Ritesh Salve, student from the Mr. Prajwal Rahane, FY (K- ECE) class was called for interrogation. He also narrated the incidence in the same way as Miss. Dhanashri Thakare told. He also added the Mr. Prajwal Rahane, FY (K- ECE) pushed the Mrs. Megha Kurhe and didn't said sorry to her.
- 4. Other students i.e. Mr. Thube Shreyash, Miss Dhanashree Shirole from FY (K- ECE) class were also called for interrogation. They told that they have not seen anything. However, few general questions concerning to character analysis were asked by Mrs Shraddha Jawad, Advocate. According to them the behavior of Mr. Prajwal Rahane in class is normal with other boys and girls students, also attend the class attentively.
- 5. Then Mr. Prajwal Rahane, FY (K- ECE) was called for interrogation. During it, he confessed the misbehavior and apologized Mrs. Megha Kurhe.

- 6. Mrs. Megha Kurhe accepted his apology.
- All committee members warned him to not to repeat the thing in future and till graduation he
 will only focus on the studies.
- Committee members also asked faculties concerning to the same class to observe Mr. Prajwal Rahane's behavior henceforth.
- As Mrs. Megha Kurhe, Assistant Professor, Dept. of IT accepted Mr. Prajwal Rahane's apology, committee members have given following recommondation

Recommendation: The suspension of Mr. Prajwal Rahane FY (K- ECE) shall be cancelled and he is allowed to attend the classes from


